The name of this corporation is GEORGE RANCH COMMUNITY ASSOCIATION. (hereinafter referred to as the "Association").

- A. The Association is a nonprofit mutual benefit corporation organized under the Nonprofit Mutual Benefit Corporation Law. The purpose of the Association is to be engaged in any lawful act or activity for which a corporation may be organized under such law.
- B. The specific and primary purposes for which the Association is formed are (i) to be a residential real estate management association, (ii) to provide for the acquisition, construction, management, maintenance and care of real and personal property held by the Association or commonly held by the members of the Association or located in the development and privately held by the members of the Association, and (iii) otherwise to act and be operated as a "homeowners association" as defined in Section 528 of the Internal Revenue Code of 1954, as amended.
- C. Subject to the provisions of the Declaration of Covenants, conditions and restrictions applicable to the development to be recorded in the Schoma County Records, and

any amendments, modifications or successors thereto (here-inafter referred to as the "Declaration"), the general purposes and powers of the Association are (i) to maintain architectural control, (ii) enforce protective restrictions, and (iii) promote the general welfare of the community comprising the Association.

III

The Association shall not provide or maintain facilities to provide utilities for its members.

IV

No part of the net earnings of the Association shall inure (other than by acquiring, constructing or providing management, maintenance and the care of property held by the Association, commonly held by the members of the Association, and other than by a rebate of excess membership dues. fees or assessments) to the benefit of any private member or individual.
